

2019-20 access and participation plan monitoring

Provider impact report

This impact report summarises the progress made by Activate Learning against targets, objectives and written commitments set out in its 2019-20 access and participation plan. This document is a summary of information submitted by the provider to the OfS. This document is a self-report by the provider only and does not indicate any OfS assessment of compliance.

1. Ambition and strategy

Activate Learning's ambition and strategy as detailed in the 2019-20 access and participation plan:

The 2019-20 Access and Participation Plan was originally developed by the former Guildford College Group and adopted by Activate Learning upon the merger of the two groups in March 2019. This has resulted in two targets in the plan not being taken forward (T16a_06 and T16a_07).

Activate Learning is a forward-thinking education group that is ambitious in its mission to transform lives through learning. The strategy behind the Access and Participation Plan for 2019/20 was to achieve that by enabling opportunities, creating life chances and generating prosperity for individuals and communities. Activate Learning is committed to advancing equality of opportunity, respecting and celebrating difference, eliminating discrimination, harassment and victimisation and fostering good relations.

The ambition described in the plan was therefore to create a evidenced based approach through the establishment of a comparative data set. This will underpin Activate Learning's future planning as it strives to respond flexibly and with agility to student feedback ensuring that steps are taken which are data informed.

The tables that follow provide a self-assessment by Activate Learning of progress against the targets approved in its 2019-20 access and participation plan.

Annex A: Commentary on progress against targets

Activate Learning's commentary where progress against targets was less than expected.

Target reference number: T16a_01

How have you met the commitments in your plan related to this target?

Performance has not met target although the commitments in the plan have been delivered.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

Activate Learning has reviewed its curriculum and also engagement activity to evaluate the impact of current activities in relation to this target.

Target reference number: T16a_02

How have you met the commitments in your plan related to this target?

Performance has not met target although the commitments in the plan have been delivered.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

There has been an increase of 5.4pp to 12.4% although it remains below the benchmark. This improvement is significant and has been primarily driven by changes in provision as a result of a review of the curriculum and engament activity.

Target reference number: T16a_04

How have you met the commitments in your plan related to this target?

Performance has been below target primarily due to the focus of the higher education curriculum on vocational/employer led provision offered across the Activate Learning Group. All commitments within the plan have though been delivered.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

Performance in areas where Activate Learning provides progression routes into higher education has been strong as evidenced in counselling where 61% of Level 3 students progressed on to a higher education programme.

How have you met the commitments in your plan related to this target?

Performance has been below target and not all commitments in the plan were delivered due in part, to the COVID-19 pandemic and students seeking to take a break from studies.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

This was mainly impacted by students studying HNC programmes on a part time basis who were combining study with employment.

How have you met the commitments in your plan related to this target?

This target has not been met due to the merger of the Guildford College Group with Activate Learning during the life of the plan and the result that the target was deeemed no longer appropriate.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

Following the merger of the former Guildford College Group with Activate Learning in March 2019 a database has been developed which covers all 7 colleges within the Activate Learning Group. This addresses the intent behind this target.

This target has not been taken forward following the merger of the former Guildford College Group with Activate Learning as it does not fit with the Group's HE strategic plan and/or the APP targets identified and set within the Group's 2020/21 approved Access and Participation Plan.
